



CONCESSION AGREEMENT (B.O.T.)

This agreement made at Aurangabad on this \_\_\_\_\_\_ day of \_\_\_\_\_\_ 2012 between the Commissioner of Aurangabad Municipal Corporation herein after referred to as "A.M.C." (Which expression shall unless repugnant to the context or meaning thereof shall include its administrators, successors and assigns) of One Part.

AND

M/s. Shreehari Associates (P) Ltd a company registered under the Companies Act. 1956 (1 of 1956) / Indian Companies Act. 1913 (VII of 1913), a Company having the incorporated office at 1, Sai Vrindavan, Near Mahanubhav Aashram, Paithan Road, Itkheda, Aurangabad- 431 005 at hereinafter referred to as "the Concessionaire: (which expression shall unless repugnant to the context or meaning thereof shall include it administrators, successors and assigns) of the other part.

WHEREAS The Aurangabad Municipal Corporation invited proposals for undertaking the work of "For lease of Developed land for weekly market at Shahnoorwadi of the Municipal Corporation Aurangabad." hereinafter referred to as "the project on Finance Build Transfer basis as per Notice inviting Bids No. AMC/E-Tender/2011/100, dated 07/01/2012 issued by A.M.C.

M/s Shreehari Associates (P) Ltd, Aurangabad the Concessionaire/s has interalia submitted his / their bid the for project which has been accepted by the AMC on the terms and conditions contained hereunder.

#### THE PROJECT/ SCOPE OF WORK: -


Aurangabad Municipal Corporation wants to allot the developed land at Shahanoorwadi to private agency / entrepreneur /Bidder on B.O.T. basis for thirty years only. The successful agency / entrepreneur /Bidder will have to arrange his own finance/funds to provide detachable prefabricated gala covers to minimum 1000 gala's [or cover area by non detachable prefabricated to cover a gala to perform activity; as per layout size of gala 1.8x2.4mtr.accessible by minimum 3.00mtr. wide pathway';] as per specifications submitted with tender by tenderer. The successful agency / entrepreneur/Bidder can recover his investment, annual rent payment to A.M.C. and his other maintenance expenses etc by letting-out the lease developed land to the occupants of his choice for six days in week other than Monday.

The successful agency / entrepreneur / bidder will have to use the developed land on Monday for vegetable weekly market only on every Monday and other days as per D.C.rules only as per instruction of AMC. The possession of land of A.M.C. will be handed over to successful agency / entrepreneur / bidder after signing of agreement and fulfilling all tender conditions. The fabrication (detachable) of weekly market gala covers should be done as per specifications under supervision of A.M.C. Engineers. (it is necessary to submit structural engineer certificate for safety of fabricated gala's)

The rates of gala shop will be decided by A.M.C not more than RS.50/-per gala of size 1.80x2.40 0mtr.Rates will be increased by 12% after every three years.

(Slaughter of all kinds of animals, kadba market & fish market prohibited)

and whereas the occupant has approached the concessionaire / bidder to enter into this concession agreement (B.O.T.) in respect of vegetable market, open space survey no.12 admeasuring 10000sq.mtm out of which 2000sq.mtm



should be kept for parking, with the several covenants and conditions hereafter appearing and agreed to by and between the parties and execute this concession agreement deed.

- The contract documents shall be deemed to form and be read and construed as part of this agreement (all these documents and letters are hereinafter collectively referred to as "contract Documents")
- 2. Other documents such as additional details of the proposal, security Deposit, and other correspondence between the A.M.C. and the concessionaire / bidder are as Reference Documents.
- The words and expressions used in this Concession Agreement shall have the same meaning as are respectively assigned to them in the contract documents.
- 4. Aurangabad Municipal Corporation in consideration of the Concessionaire, having agreed to accept payment of Rs.21,60,000=00 (Rupees Twenty One lacs Sixty Thousand only) as nonrefundable deposit for grant of right to develop and complete the project in conformity with the provisions of the contract Documents hereby grants the Concessionaire / bidder the right to develop the project.
- 5. The Concessionaire / bidder does hereby agree:
  - a) To duly execute and complete the project in all respect entirely at the cost of the concessionaire / bidder and strictly in accordance with the approved designs, drawings and works specifications under technical control and supervision of the A.M.C. and within the time limits specified therein agreement. If work is not completed within stipulated time then heavy penalty will be imposed and agreement will be canceled or any other suitable action will be taken by AMC.
  - b) To duly observe and perform all the terms and conditions in the contract documents.
  - c) Paid the performance security deposit amounting to Rs. 5,00,000=00 (Rupees Five lacs only) in the form of a Bank Guarantee of an equivalent amount.
  - To develop shahnoorwadi vegetable market and enter into agreement(s) provided in the Contract Documents with A.M.C. and This contract Agreement shall be governed by and constructed in accordance with laws of the republic of India.
