The Aurangabad Municipal Corporation will allow the private entrepreneur/bidder to recover his investment by giving the private entrepreneur/bidder the right to lease out the bidder component of Shopping Complex at Vasant Bhavan, Aurangabad on plot area Admeasuring 1418.00 Sq.mtr The successful entrepreneur/ bidder will be responsible for the construction of the Commercial Complex at Vasant Bhavan, Aurangabad, by his own funds. The Aurangabad Municipal Corporation owner of plot of project will allow the successful entrepreneur/bidder to recover his investment by giving the successful entrepreneur/bidder the right to lease out bidder component from the Commercial Complex at Vasant Bhavan, Aurangabad having area of plot admeasuring 1418.00 Sq.mtr for which allowable built-up 2127.00 Sq.mtr on a Long Term Lease of 30 years to occupants of his choice on payment of nonrefundable deposit to recover his investment on the bidder component. ### 7) Settlement of disputes

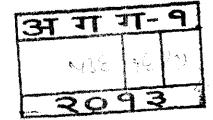
